On September 13, 2021 BlueBit Networks, LLC (“the Company”) pursuant to Section 392.550, RSMo, filed an application for certificate of service authority to provide Basic Local Telecommunications Services in the following exchanges:

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo.
