ORDER DIRECTING NOTICE OF APPLICATION AND ESTABLISHING INTERVENTION FILING DATE

Issue Date: June 6, 2018 Effective Date: June 6, 2018

On June 4, 2018, Union Electric Company d/b/a Ameren Missouri applied to the Commission for approval of a Missouri Energy Efficiency Investment Act (MEEIA) plan. This proposed plan to be effective for the period of March 1, 2019 through December 31, 2024 includes a Demand-Side Investment Mechanism (DSIM), a Demand-Side Management Portfolio Plan, and variances from certain Commission rules. Ameren Missouri also included a proposed procedural schedule.

As part of the proposed procedural schedule, Ameren Missouri requested a shortened intervention time, an early prehearing conference, and a technical conference with the Staff of the Missouri Public Service Commission and interested parties during the week of June 19, 2018. The Commission will provide notice of Ameren Missouri's application to potentially interested individuals and entities and will invite them to apply to intervene as parties. The Commission will also set an early prehearing conference.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall send a copy of this order to each party in File Nos. EO-2015-0055 and ER-2016-0179, to the county commission of each county within Ameren Missouri's service area, and to the corresponding governmental body serving the City of St. Louis.
- 2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing the counties within Ameren Missouri's service area, and to the news media serving that service area.
 - 3. Applications to intervene shall be filed no later than June 18, 2018.
- 4. The parties shall appear at a procedural conference to be held on June 19, 2018 at 1:00 p.m. Any applicant for intervention may also appear regardless of whether intervention has been granted.
- 5. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Such contact shall be through the Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711.
- 6. The parties and potential intervenors may also attend the early prehearing conference via telephone by calling 877-820-7831 and entering the access code 35666479# at the time set for the beginning of the conference.
