**THE COMMISSION ORDERS THAT:**

1. No later than May 29, 2018, Staff shall file the Staff report of deficiencies, and any interested person may file comments.

2. The Commission’s Data Center shall deliver this order to each party to the action in File No. ER-2018-0146 and to each county commission of any county within KCP&L Greater Missouri Operations’ service area (“the service area”).
