## ORDER CREATING A TRAINING ADVISORY GROUP

In its Report and Order issued in Union Electric Company, d/b/a Ameren Missouri's most recent rate case, File No. ER-2011-0028, the Commission stated its intent to create a Training Advisory Group to provide input to Ameren Missouri on the design, implementation, and evaluation of the company's additional training programs authorized under that and previous rate case orders. The Commission did not explicitly create the Training Advisory Group in the rate case report and order and on October 6, 2011, the Staff of the Commission and the unions that represent many of Ameren Missouri's workers filed a joint motion in File No. ER-2011-0028 asking the Commission to establish the promised Training Advisory Group. Rather than issue an additional order in the closed rate case, which is currently under appeal, the Commission has created this case to address the joint motion of Staff and the unions.

The Commission will create the Training Advisory Group it described in its report and order in File No. ER-2011-0028.

## THE COMMISSION ORDERS THAT:

- 1. A Training Advisory Group is created to provide input to Union Electric Company, d/b/a Ameren Missouri on the design, implementation, and evaluation of the company's additional training programs authorized in the Commission's Report and Order in File No. ER-2011-0028 and previous Ameren Missouri rate cases.
- 2. The initial members of the Training Advisory Group are Union Electric Company, d/b/a Ameren Missouri, the Staff of the Commission, the Office of the Public Counsel, and the unions that represent Ameren Missouri's workers, specifically, International Brotherhood of Electrical Workers Locals 2, 309, 649, 702, 1439, 1455, AFL-CIO and International Union of Operating Engineers Local 148, AFL-CIO.
- 3. Other entities may also participate in the Training Advisory Group if the advisory group agrees that such participation is appropriate.
- 4. The members of the Training Advisory Group shall meet at such times as they may agree upon.
- 5. The Training Advisory Group may report to the Commission periodically as it deems appropriate.
- 6. If the Training Advisory Group is unable to reach agreement on any issue related to the training program, any member may petition the Commission for further direction.
- 7. The Commission's Data Center shall make Union Electric Company, d/b/a Ameren Missouri, the Staff of the Commission, the Office of the Public Counsel, and the unions that represent Ameren Missouri's workers, specifically, International Brotherhood of

Electrical Workers Locals 2, 309, 649, 702, 1439, 1455, AFL-CIO and International Union of Operating Engineers Local 148, AFL-CIO parties to this case.

- 8. The Commission's Data Center shall provide a copy of this order to all other parties to File No. ER-2011-0028.
  - 9. This order shall become effective immediately upon issuance.
