**ORDER EXTENDING TIME FOR FILING OF STAFF RECOMMENDATION**

On September 4, 2018, Pro Builders since 1994 LLC filed an application with the Missouri Public Service Commission requesting that its electric supplier be changed from Kansas City Power & Light Company to Platte-Clay Electric Cooperative, Inc. On September 6, 2018, the Commission issued a *Notice of Deficiency*, and on September 28, 2018, Pro Builders since 1994 LLC filed a corrected application. The Commission directed its Staff to file a recommendation regarding the application no later than November 1, 2018. On November 1, 2018, Staff filed a *Motion for Extension* indicating that it has not completed its review of the application as the deadline for responses of other parties was also due November 1, 2018, which did not give Staff sufficient time to review and prepare their response. The Commission will extend the deadline for Staff to file its recommendation.

**THE COMMISSION ORDERS THAT:**

1. The deadline for the Staff of the Commission to file a recommendation regarding Pro Builders since 1994 LLC's application is extended to no later than November 15, 2018.

2. This order shall be effective when issued.
