# ORDER GRANTING AN EXTENSION OF TIME TO FILE PROGRAM YEAR 3 EVALUATION, MEASUREMENT, AND VERIFICATION REPORT

Issue Date: March 1, 2023 Effective Date: March 1, 2023

On February 14, 2023, Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed a motion requesting a 30-day extension of time to file its Program Year 3 Evaluation, Measurement, and Verification Report (EM&V Report). In support of its position, Evergy states that due to a large number of year-end project completions it needs additional time to provide its PY3 EM&V Report to all parties and the Commission. Evergy's motion states that it has conferred with the Commission's Staff, who does not oppose the extension.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. The Commission received no responses to Evergy's request.

The Commission finds Evergy's request reasonable and will grant the requested extension and additionally extend the time to file any PY3 EM&V Report change requests with the Commission an additional 30 days.

#### THE COMMISSION ORDERS THAT:

- 1. Evergy's motion for an extension is granted. Evergy shall file its PY3 EM&V Report no later than July 31, 2023.
- 2. The Commission will extend the time to file any PY3 EM&V Report change requests by an additional 30 days.
