ORDER ESTABLISHING TIME TO RESPOND

On December 12, 2022, Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("EMM") and Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("EMW") filed tariffs with effective dates of January 11, 2023, that will extend certain MEEIA 3 programs until December 31, 2023. Also on December 12, 2022, EMM and EMW filed a motion asking the Commission to expedite its approval of the filed tariffs so that they can go into effect on January 1, 2023, thereby avoiding a gap in the availability of MEEIA 3 programs.

The Commission will direct its Staff to file an expedited recommendation regarding the filed tariffs and will establish a date by which any other party may respond to those tariffs.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendations regarding the tariffs filed by EMM and EMW (Tracking Nos. YE-2023-0109 and YE-2023-0110) no later than December 16, 2022.

2. Any other party wishing to respond to the tariffs filed by EMM and EMW (Tracking Nos. YE-2023-0109 and YE-2023-0110) shall do so no later than December 16, 2022.

3. This order shall be effective when issued.
