On June 22, 2022, Union Electric Company d/b/a Ameren Missouri filed a notice of change in its preferred resource plan pursuant to the Commission's Integrated Resource Planning rule - 20 CSR 4240-22.080(12). That rule requires an electric utility to notify the Commission if it determines that its previously identified resource plan is no longer appropriate. Ameren Missouri's filing informed the Commission that it had determined that it was necessary to retire the Rush Island Energy Center to comply with federal court requirements. Ameren Missouri submitted a new preferred resource plan along with its June 22 filing.

The Commission's rule requires the utility to file notice of its new preferred resource plan, but it does not require the Commission to approve, reject, or take any other action regarding that plan. Consequently, no action by the Commission is required, and this file shall be closed.
