SUBJECT: Staff Recommendation For **Approval** Of Tariff Sheet Correcting Typographical Error Found on P.S.C. MO. No. 1 7th Revised Sheet No. 6.10 Canceling 6th Revised Sheet No. 6.10

DATE: June 21, 2011

On June 9, 2011, KCP&L Greater Missouri Operations Company (“GMO”) filed with the Commission one (1) revised tariff sheet bearing an issue date of June 9, 2011, and an effective date of July 9, 2011. The purpose of the proposed tariff revision is to correct a typographical error found to be contained on P.S.C. MO. No. 1 7th Revised Sheet No. 6.10 Canceling 6th Revised Sheet No. 6.10. The “Last Effective Date” of the quarterly cost adjustment (QCA) for the first quarter of 2011 was given as 5/31/2011 on the 7th Revised Sheet No. 6.10. Instead, that date should read 5/31/2012, as it does on the 8th Revised Sheet No. 6.10, Tariff Tracking No. YH-2011-0622.

Staff has reviewed the filed tariff sheet and recommends the Commission **approve** the following proposed tariff sheet, as filed on June 9, 2011, to become effective on July 9, 2011, as requested by GMO, or permit the tariff sheet to go into effect on July 9, 2011, by operation-of-law:

Staff has verified that GMO is not delinquent on any assessment and has filed its 2010 annual report. GMO is current on its submission of its Surveillance Monitoring reports as required in 4 CSR 240-20.090(10) and its monthly reports as required by 4 CSR 240-3.161(5). Staff is not aware of any other matter pending before the Commission that affects or is affected by this tariff filing except for the Complaint By AG Processing, Inc., A Cooperative Concerning Recoveries From Steam Customers Of Imprudently Incurred Amounts By Aquila, Inc. And Its Successors Including KCP&L Greater Missouri Operations Company in Case No. HC-2010-0235.

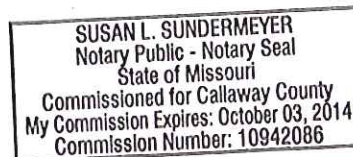

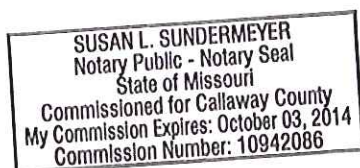
