On June 9, 2011, KCP&L Greater Missouri Operations Company ("GMO") filed with the Commission one (1) revised tariff sheet bearing an issue date of June 9, 2011, and an effective date of July 9, 2011. The purpose of the proposed tariff revision is to correct a typographical error found to be contained on P.S.C. MO. No. 1 7<sup>th</sup> Revised Sheet No. 6.10 Canceling 6<sup>th</sup> Revised Sheet No. 6.10. The "Last Effective Date" of the quarterly cost adjustment (QCA) for the first quarter of 2011 was given as 5/31/2011 on the 7<sup>th</sup> Revised Sheet No. 6.10. Instead, that date should read 5/31/2012, as it does on the 8<sup>th</sup> Revised Sheet No. 6.10, Tariff Tracking No. YH-2011-0622.

Staff has reviewed the filed tariff sheet and recommends the Commission **approve** the following proposed tariff sheet, as filed on June 9, 2011, to become effective on July 9, 2011, as requested by GMO, or permit the tariff sheet to go into effect on July 9, 2011, by operation-of-law:
