ORDER GRANTING APPLICATIONS TO INTERVENE

On June 22, 2022, Union Electric Company d/b/a Ameren Missouri filed a notice of change in its preferred resource plan pursuant to the Commission's Integrated Resource Planning rule - 20 CSR 4240-22.080(12). On July 11, Renew Missouri Advocates d/b/a Renew Missouri (Renew Missouri) and the Missouri Department of Natural Resources – Division of Energy (DE) applied to intervene. More than ten days have passed and no one has responded to either motion to intervene.

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing Renew Missouri and DE to participate will serve the public interest. The Commission will grant the applications to intervene.

THE COMMISSION ORDERS THAT:

- 1. Renew Missouri's application to intervene is granted.
- 2. DE's application to intervene is granted.
