On November 23, 2022, Union Electric Company d/b/a Ameren Missouri filed a request for the Commission to grant it a variance from a portion of Commission Rule 20 CSR 4240-23.020, specifically the chart titled “Electrical Corporation System Inspection Cycles.” Ameren Missouri seeks to modify the inspection frequency contained in that chart. Ameren Missouri also request a waiver of the 60-day notice requirement of 20 CSR 4240-4.017(1).

The Commission will provide notice to potentially interested parties, and will establish an intervention deadline. The Commission will also direct its Staff to file a recommendation about Ameren Missouri’s request.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Data Center shall provide a copy of this order to all parties to Ameren Missouri’s current general rate case, File No. ER-2022-0337.
2. Any proper person or entity wishing to intervene in this matter shall file an application to do so no later than December 20, 2022.
3. Staff shall file its recommendation about Ameren Missouri’s request or a status report no later than December 20, 2022.

4. This order is effective when issued.
