Title 4—DEPARTMENT OF ECONOMIC DEVELOPMENT Division 240 – Public Service Commission Chapter 2 – Practice and Procedure

4 CSR 240-30.040 Uniform System of Accounts, Class A and Class B Telecommunications Companies. This rule adopted the Federal Communications Commission's Part 32 uniform system of accounts, regarding the filing of annual reports and the maintenance of books and records of companies regulated by both the FCC and the Missouri Public Service Commission. This rule also set forth a uniform system of accounts for Class A and Class B telecommunications companies regulated by the Missouri Public Service Commission. This rule also prescribed that, unless otherwise directed by the commission, certain telecommunications companies develop surrogates to approximate the capital to expense shifts resulting from the use of Part 32, and that all Class B telecommunications companies keep their plant accounts in Part 32, Class A detail.

PURPOSE: This rule is rescinded in its entirety because the subject matter is no longer within the Missouri Public Service Commission's authority as described in Section 392.611.

PUBLIC COST: This proposed rescission will not cost state agencies or political subdivisions more than five-hundred dollars (\$500) in the aggregate.

PRIVATE COST: This proposed rescission will not cost private entities more than five-hundred dollars (\$500) in the aggregate.
