Broadview Networks, Inc. ("Broadview" or "Applicant") hereby respectfully requests a waiver of the requirement of Commission Rule 4 CSR 240-3.510(1)(D), which requires certain pro forma financial information in connection with an application for Certificate of Service Authority to Provide Basic Local Telecommunications Services. On October 27, 2009, Broadview submitted an Application for Basic Local Telecommunications Service Authority, assigned Case No. 2010-0126 by the Commission. As part of that Application, Broadview provided a Securities and Exchange Commission Form 10-Q which contains actual financial information which demonstrates the sufficiency of Broadview's technical, financial and managerial resources and ability to provide basic local telecommunications services in Missouri.

Broadview has not developed pro forma financial information specifically related to the Company's proposed local service offering in Missouri and respectfully requests that the Commission grant a waiver of Commission Rule 4 CSR 240-3.510(1)(D) to enable the above-referenced application to proceed without the development and submission of pro forma

financial materials. In support of the sufficiency of its financial resources, Broadview also submits the attached Affidavit of Financial Sufficiency.
