On November 23, 2022, Union Electric Company d/b/a Ameren Missouri filed an application with the Commission asking for a variance from a portion of Commission Rule 20 CSR 4240-23.020. On January 11, 2023, Ameren Missouri filed a dismissal with the Commission indicating that due to other matters pending before the Commission, it wished to dismiss this case and would refile at a later date.

Commission Rule 20 CSR 4240-2.116(1) states that a party may dismiss an application without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission will take notice of the dismissal, and this file shall be closed.
