AMICUS CURIAE BRIEF OF SSM HEALTH

Need for the Facilities And Public Interest Served

A core value to SSM Health is Stewardship, which means a commitment by SSM Health to "use financial, human and natural resources responsibly and care for the environment." As such, SSM Health supports the increased utilization of renewable energy in Missouri and the Midwest region.

The Grain Belt Express Clean Line will allow for the delivery of low-cost, renewable energy into Missouri, and result in a reduction on the use of fossil fuels to generate electricity. Grain Belt Express witness Neil Copeland explains in his Direct Testimony and Schedules how this project will reduce emissions from electric generation in Missouri by utilizing more non-polluting wind energy and less fossil-

fuel based generation (primarily from coal). Emissions from the burning of fossil-fuels are known to reduce air quality and also cause health concerns.

In addition, as a consumer of electricity in Missouri, accessing renewable energy at low rates is consistent with SSM Health's business and mission objectives.
