## ORDER GRANTING, IN PART, AND DENYING, IN PART, MOTION FOR EXCUSAL OF ASSOCIATED COUNSEL

On February 28, 2018, the Federal Executive Agencies ("FEA") filed a *Motion for Excusal of Associated Counsel*, requesting that the Commission excuse FEA's designated Missouri attorney, Major Thomas Schmidt, from appearing on behalf of FEA in all proceedings and participating in all filings pertaining to this case. Missouri Supreme Court Rule 9.03(c)(3) provides that designated associate counsel shall sign all pleadings, briefs, and other filed or served documents and, unless excused by the judge or presiding officer, be present at all hearings. The Commission finds that under this rule it has the discretion to excuse Major Schmidt from appearing at any hearings in this matter, and will grant the request excusing Major Schmidt from appearing at the evidentiary hearing. However, the Commission does not have the discretion to excuse Major Schmidt from signing all pleadings and briefs, so the Commission will deny that request.

#### THE COMMISSION ORDERS THAT:

1. The Federal Executive Agencies' *Motion for Excusal of Associated Counsel* granted, in part, and denied, in part, as described in the body of this order.

2. This order shall be effective when issued.
