ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, DIRECTING FILING AND SCHEDULING A CONFERENCE

On December 6, 2012, Union Electric Company d/b/a Ameren Missouri filed an application for a Certificate of Public Convenience and Necessity to construct, install, own, operate, control, manage and maintain a 345,000-volt overhead electric transmission line located in Cape Girardeau County, Missouri.

The Commission will give notice of the application to potentially interested persons and entities, set an intervention deadline and schedule a procedural conference. Additionally, the Commission shall direct its Staff to investigate and file a report and recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order and the application to the parties to Union Electric Company d/b/a Ameren Missouri's on-going rate case, File Number ER-2012-0166.

2. The Commission's Data Center shall provide notice and serve a copy of this order upon the county commission of each county within Ameren Missouri's service area,

the County Commission of Cape Girardeau County, Missouri, and the corresponding governing body for the City of St. Louis.

3. The Commission's Public Information Office shall make notice of this order available to the media in the service area of Union Electric Company d/b/a Ameren Missouri and to the members of the General Assembly representing this service area.

4. The Commission's Public Information Office shall make notice of this order available to the media in Cape Girardeau County, Missouri and to the members of the General Assembly representing this area.

5. Notice may be provided electronically.

6. No later than December 17, 2012, the Staff of the Missouri Public Service Commission shall identify any other entity that should receive notice of this application.

7. Any person or entity wishing to intervene in this matter shall file an application no later than January 2, 2013 with:
