On June 30, 2017, The Empire District Electric Company, The Empire District Gas Company, Liberty Utilities (Midstates Natural Gas) Corp., and Liberty Utilities (Missouri Water) LLC, all subsidiaries of Algonquin Power & Utilities Corp., filed an application with the Missouri Public Service Commission seeking approval of their Cost Allocation Manual.

The Commission will provide notice of the joint application to potentially interested parties and set a deadline for intervention requests. If no proper party requests a hearing, the Commission may determine that a hearing is not necessary for a determination of the application.¹
