ORDER REVISING PROCEDURAL SCHEDULE

Effective Date: December 3, 2015

The Commission established a procedural schedule and other procedural requirements in this matter on September 23, 2015. The procedural schedule was subsequently suspended on October 22, 2015. After objections were filed to a non-unanimous stipulation and agreement, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company filed a joint revised procedural schedule on November 30, 2015. The Commission will adopt the revised procedural schedule with some modifications.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is revised, as follows:

Dec. 11, 2015	Direct testimony in support of stipulation
Dec. 21, 2015	Rebuttal testimony
Dec. 31, 2015	Surrebuttal testimony
Jan. 5, 2016	List of issues, list and order of witnesses, order of parties for cross-examination, and order of opening statements
Jan. 6, 2016	Position statements
Jan. 12, 2016	Evidentiary hearing
Jan. 29, 2016	Initial briefs
Feb. 5, 2016	Reply briefs

2. The evidentiary hearing is scheduled for January 12, 2016, beginning at 8:30 a.m. The hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. 3. In the Order Establishing Procedural Schedule and Other Procedural Requirements issued on September 23, 2015, the first sentence of ordered paragraph 4(K) is amended to: "Each party shall prepare a list of its pre-filed, pre-marked exhibits and submit a copy of that list to every other party and to the regulatory law judge no later than January 11, 2016."

4. All other procedural requirements in the Order Establishing Procedural Schedule and Other Procedural Requirements, issued on September 23, 2015, that are not revised in this order shall remain unchanged.

5. This order shall be effective when issued.
