ERRATUM TO THE STAFF REPORT REVENUE REQUIREMENT COST OF SERVICE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, for its Erratum to the Staff Report Revenue Requirement Cost of Service, states:

1. On page 1 at lines 11-12 in the Executive Summary section of the Staff Report Revenue Requirement Cost of Service as filed December 18, 2009, the Staff states, “The Staff’s recommended revenue requirement for AmerenUE is \$190,395,678 to \$200,000,000 based on a return on equity (ROE) range of 9.00% to 9.70%.” The recommended revenue requirement range of “\$190,395,678 to \$200,000,000” stated there is wrong. The correct Staff recommended revenue requirement for AmerenUE based on a return on equity (ROE) range of 9.00% to 9.70% is a range of \$218,207,027 to \$250,800,449, as correctly shown on line 12 of filed Staff Accounting Schedule 1 (low, midpoint and high rate of return, respectively) as follows: **“12 Gross Revenue Requirement \$218,207,027; \$234,503,738; \$250,800,449.”** The correct amounts for the Staff’s revenue requirement range are also shown in the direct testimony of Staff witness Stephen M. Rackers at page 10, lines 11 through 14: “This Accounting Schedule shows that the Staff’s recommended revenue requirement for AmerenUE in this proceeding ranges from approximately \$218,207,027 to \$250,800,449, based upon a recommended rate of return (ROR) range of 7.39% to 7.72%.” Therefore, on line 12 in the Executive Summary section of the Staff Report Revenue Requirement Cost of Service the dollar range of “\$190,395,678 to \$200,000,000” is incorrect and should be replaced with the dollar range “\$218,207,027 to \$250,800,449.”

2. Therefore, the Staff's erratum to the Staff's Revenue Requirement Cost of Service Report follows:
