On September 13, 2021, the Staff of the Commission filed a motion requesting a 30-day extension of time in which to make a filing regarding Union Electric Company d/b/a Ameren Missouri's *Application for Modification of Demand Side Management Plan* filed on July 2, 2021. Staff states that it has been in discussions with the parties and expects to "file a stipulation in lieu of any recommendations."<sup>1</sup> The Commission will grant the extension of time.

1. No later than October 13, 2021, the Staff of the Commission shall file either a recommendation, stipulation, or further status report regarding Ameren Missouri's application.
