FOURTH ORDER GRANTING STAFF'S MOTION FOR AN EXTENSION OF TIME TO FILE A PROPOSED PROCEDURAL SCHEDULE

On February 28, 2022, the Commission directed its Staff (Staff) to file a proposed procedural schedule on behalf of the parties no later than March 17, 2022. That deadline was extended three times to April 21, 2022.

On April 21, 2022, Staff filed another request for an extension. In support of its request Staff offers that settlement discussions continue. Staff requests until April 28, 2022, to file a settlement agreement or a proposed procedural schedule. The Commission will grant the extension.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file a settlement agreement or a proposed procedural schedule no later than April 28, 2022.
