**ORDER APPROVING MODIFICATIONS TO EVERGY MISSOURI METRO
AND EVERGY MISSOURI WEST'S TECHNICAL RESOURCE MANUAL**

Issue Date: December 15, 2021

Effective Date: January 1, 2022

On November 18, 2021, Evergy Missouri Metro and Evergy Missouri West (Evergy) filed an application and supporting exhibits for approval of modifications to its Technical Resource Manual (TRM) to incorporate final Evaluation, Measurement, and Verification (EM&V) results from program year 1 of Evergy's Missouri Energy Efficiency Investment Act (MEEIA) Cycle 3. The TRM sets forth measures, the level of energy savings, incremental costs, and effective, useful lives associated with each measure. The TRM is also used to calculate throughput disincentive on a future basis.

The Commission established a deadline for any responses or recommendations concerning Evergy's TRM. The Commission received no responses.

Evergy represents that the proposed TRM updates were provided to the Staff of the Commission who did not have any concerns. The TRM updates were also reviewed by the Third-Party Evaluators: Guidehouse, Inc, and ADM Associates.

The Commission, having reviewed the Application, concludes that the modified TRMs should be approved to become effective January 1, 2022, so that MEEIA program

tracking data, and program evaluation data align. The Commission will make this order effective January 1, 2022, to coincide with the TRMs' effective date.

THE COMMISSION ORDERS THAT:

1. The request to approve Evergy's modified Technical Resource Manual is granted. The modified Technical Resource Manual is effective on and after January 1, 2022.
2. This order shall be effective on January 1, 2022.
