ORDER SETTING TIME FOR RESPONSES TO TARIFF REVISION

Issue Date: September 12, 2022

Effective Date: September 12, 2022

On September 9, 2022, Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed tariff revisions and a motion for expedited treatment. Those tariff revisions bear an effective date of October 9, 2022, but Evergy has asked that the Commission allow the tariff revisions to become effective on September 25, 2022. In support of its request, Evergy states that the current Pay As You Save (PAYS®) tariff sheet expire on September 25, 2022 (though the expiration date actually appears to be September 30, 2022). Evergy's motion states that the Staff of the Commission and the Office of the Public Counsel do not object to Evergy's motion. The tariff revisions' only changes appear to be the issuance dates, the effective dates, and a change of the end dates for the pilot program. Evergy's requested effective date necessitates the shortening of time for any responses to either the tariff revisions or the motion for expedited treatment.

THE COMMISSION ORDERS THAT:

1. Any responses to the tariff sheets or Evergy's motion shall be filed no later than September 13, 2022.
2. This order is effective when issued.
