On May 18, 2017, IRU Networks, LLC ("Applicant") filed an application with the Missouri Public Service Commission ("Commission"), requesting that the Commission issue an order granting it a certificate of service authority to provide resold and facilities-based/UNE basic local telecommunications services in portions of the state of Missouri; grant competitive status to Applicant and classify Applicant's services as competitive; and waive certain Commission rules and statutory provisions.
