- 1. Call One regretfully acknowledges that it failed to timely file its 2012 Annual Report with the Commission due to administrative error. Call One was unaware of its error, or of Staff's *Motion to Cancel Certificate of Service Authority and Associated Tariff* in this matter, until notified on November 10 by undersigned counsel who had seen notice of the issuance of the *Notice of Motion and Order Directing Response*.
 - 2. Call One filed its 2012 Annual Report with the Commission on November 12.
- 3. Call One is in the midst of active and productive discussions with Commission Staff about the possibility of Staff withdrawing its *Motion to Cancel* upon payment by Call One to the Public School Fund as a penalty for this late filing. A stipulation is in the process of being drafted to accomplish this. It is hoped that a stipulation can be filed in very early December 2013.

4. Call One has also updated its company contact information on the Commission's Electronic Filing and Information System (EFIS) and is committed to improving its internal corporate systems and procedures to ensure timely filing of future Missouri PSC Annual Reports.

WHEREFORE, Call One, Inc. respectfully requests that the Commission suspend activity in this file and refrain from any further action herein pending the filing of a stipulated resolution by Staff and Call One.
