On September 15, 2022, Jack and Tammy Duncan (Applicants) filed an application with the Missouri Public Service Commission requesting a change of electric supplier from Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy), to the Platte-Clay Electric Cooperative, Inc. (Platte-Clay). On September 19, the Commission issued its order directing the Staff of the Commission (Staff) to file a recommendation no later than November 18. On November 3, the Applicants filed a motion for continuance, asking the Commission to extend the date by which Staff's recommendation is due until May 18, 2023. On November 18, Staff filed its response to the Applicants' motion for continuance, stating that it did not object to filing its recommendation on May 18, 2023.

The Commission will grant the Applicants' motion for continuance.

THE COMMISSION ORDERS THAT:

1. The motion for continuance filed by Applicants is granted.
2. Staff shall file its recommendation regarding the application no later than May 18, 2023.
3. This order shall be effective when issued.
