On February 3, 2021, The Empire District Electric Company filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission for authority to implement demand-side programs and to establish a Demand-Side Programs Investment Mechanism (DSIM). The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.

More than 180 days have passed since Empire filed its notice and by terms of the regulation, File No. EO-2021-0247 has closed.
