On October 6, 2021, Ameren Missouri and BMU filed a joint application for approval of a territorial agreement along with the territorial agreement. The territorial agreement removes the six customers from Ameren Missouri's service territory. The Commission will issue an order directing the Staff of the Commission to file its recommendation about the application and territorial agreement or a pleading informing the Commission of the date certain it anticipates filing its recommendation.

THE COMMISSION ORDERS THAT:

1. No later than October 27, 2021, the Staff of the Commission shall file its recommendation regarding the territorial agreement or a pleading specifying the date certain it will file its recommendation.
2. This order is effective when issued.
