**ORDER DIRECTING
DATA CENTER TO SEND NOTICE**

Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company have filed an application to transfer certain assets from the former to the latter. Section 393.190.1 RSMo. requires the Missouri Public Service Commission to “send a copy off all information obtained by it as to what impact this transfer will have on the tax revenues of the political subdivisions to the county clerks of each county affected.”

In their application, KCP&L and KCP&L GMO state that the relevant assets are in Buchanan, Clay and Platte Counties. And, with regard to the tax impact, the Applicants state as follows:

The Transfer will have a minimal effect on the tax revenues on the counties in which the assets are located. Because the Alabama-Nashua Line will be sold at its book value, less the amount of depreciation reserve associated with the line, both KCP&L and GMO will pay the same amount of taxes. However, because KCP&L’s average pole mile cost is higher than GMO’s average pole mile cost, the total decrease in property taxes based on the 2011 assessments and mill levy rates would have been \$72,148 for the following tax districts where these pole miles are located, which will be offset by an increase in value to the other taxing districts served by KCP&L and GMO:
