Dear Fellow Citizens of Moberly,

70,000 Sharholders? AMEREN UE is an investor-owned utility in Missouri. This company is only obligated to those who own them. We need to create many different watch-dog operations to check and balance the investors for the best service to our community. I have lived within the AMEREN UE utility controlled community since 2004 and have watch my utility bill increase without merit or any accountability to the customers. Maybe Missourians should seek Warren Buffett to acquire AMEREN UE and provide reasonable utility rates.

We just joined the Fair Electricity Rate Action Fund (FERAF) www.fairenergyrates.org or www.fairelectricityrates.com because they have a successful record of informing the public and influencing the legislative process in order to keep electricity rates fair and affordable for Missourians. During the 2009 Missouri legislative session, FERAF mounted a successful effort in opposition to the "Construction Works in Progress" (CWIP) bill moving through the legislature at the time. FERAF is holding a special public meeting at the Moberly Area Community College Auditorium on Wednesday, February 3, 2010 at 5:30 PM.

Since 1992 to the present I have been a Private Investigator/Expert Witness/Paralegal. There is great need for a community committee to check and balance AMEREN UE. In 1983, I became personally involved in an illegal price increase attempt when my local utility company got caught in a bribery case. Since that date local residents have benefited from very low energy costs because of the demands made to prevent another illegal price hike.

Utah Power and Light (UP&L) was organized on 6 September 1912 as a subsidiary of a large holding company, Electric Bond and Share Company of New York, under the control of the President of the Mormon Church, Joseph F. Smith. Within four years of its organization, UP&L had purchased twenty-seven other electric companies in the general Utah area, and eventually absorbed more than one hundred thirty others. UP&L stock was worth \$21 per share on 01/03/83 with the major stockholder as the Mormon Church. A member of the Mormon First Presidency served on the Board of Director, Gordon B. Hinckley. In 1983 the <u>UP&L Board instructed their attorney</u>, John Preston Creer, to bribe the Utah Public Service Commission (UPSC) with \$60,000 for a price hike to increase the earning and value of their stock. UPSC attorney David Blackwell exposed the bribery and attorney Creer was disbarred (scapegoat for Gordon Hinckley) and his law firm's (Nielsen & Senior) malpractice insurance policy covered the fines and penalties.

Because of the above exposed bribery the Utah Legislators passed laws regulating UP&L operations through many check and balance processes, including a watch-dog civilian committee to make sure no secret deals were made to enhance the value of the stock by stockholders/investors. It was so successful, the Mormon Church authorized the 1987 merger of UP&L to PacifiCorp (Oregon) and today this company operates 75 generation facilities in nine western states. Since 2006, PacifiCorp has been a wholly owned subsidiary of MidAmerican Energy Holdings Company, an affiliate of Berkshire Hathaway (Warren Buffett). PacifiCorp produces cheap energy. So why would Warren Buffett want to own this company?

Control is Buffett's god/religion, the second richest man in the world from Omaha, Nebraska. Buffett was raised Presbyterian but has since described himself as agnostic (someone who is doubtful or noncommittal about the existence of God). Buffett married Susan Buffett née Thompson in 1952. They had three children, Susie, Howard, and Peter. The couple began living separately in 1977, although they remained married until her death in July 2004. In 2006, on his seventy-sixth birthday, Warren married his never-married longtime-companion, Astrid Menks, who was then sixty years old. She had lived with him since his wife's departure in 1977. Warren Buffett lives an open "image" based on his own personal life-style and income. **Background:** I grew up in Tucson, Arizona. In 1965 David Blackwell was a good friend and student body president at Amphi High School. He became a lawyer and moved to Utah where I had moved to in 1966. David Blackwell was hired by the Utah Public Service Commission as their attorney. David supplied me all the information of this bribery as a warning because I had hired the same law firm to handle a Dallas, Texas adoption for me in 1986.
