**REVISED APPENDIX B TO
UNANIMOUS STIPULATION AND AGREEMENT**

Comes now Missouri Gas Utility, Inc. (MGU or Company), and on behalf of the parties, provides to the Missouri Public Service Commission (Commission) the attached Revised Appendix B to the Unanimous Stipulation and Agreement:

1. In reviewing the regulatory law judge's questions for purposes of the Stipulation Hearing, the parties have discovered an error in the original Appendix B to the Unanimous Stipulation and Agreement. This error resulted in an understatement of the annual bills for the Large Volume class. It is shown on the original Appendix B to be 111. However, it should instead be 131. Making this correction changes the Large Volume class commodity charge from \$0.5070/ccf to \$0.5027, the same rate as the Commercial Service class. At that rate, the percentage increases in commodity charge now match for all classes except the General Service class.


2. Attached hereto is a Revised Stipulation Appendix B for consideration by the Commission that includes the above correction.

3. Counsel for both the Commission Staff and the Office of the Public Counsel indicate that they agree with this Revised Stipulation Appendix B.

4. If the Unanimous Stipulation and Agreement is approved by the Commission, MGU will file compliance tariffs that contain a Large Volume commodity rate that matches that found in Revised Stipulation Appendix B.

WHEREFORE, Missouri Gas Utility, Inc. respectfully requests that the Commission issue its Order approving all of the specific terms and conditions of the Unanimous Stipulation and Agreement and Revised Stipulation Appendix B.
