On August 25, 2021 E. Ritter Communications Holdings, LLC (“the Company”) pursuant to Section 392.550, RSMo, filed an application for certificate of service authority to provide Basic Local Telecommunications Services in the following exchanges:

AT&T Communication, CenturyLink, and Windstream service territories

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 60 days before filing the application.
