
1. The Company has main offices in Missouri located at 11422 Schenk Drive, Maryland Heights, MO 63043.





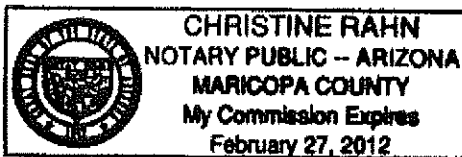
