## ORDER CANCELING REGISTRATION

Issue Date: October 12, 2018

Effective Date: October 22, 2018

On October 2, 2018, Staff filed a motion requesting the Commission cancel Blue Ocean Technologies, Inc.'s ("Blue Ocean") registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the state of Missouri. The Commission granted Blue Ocean its IVoIP registration in the state of Missouri in File No. DA-2017-0043.

Staff states in its motion that on September 19, 2018, Blue Ocean notified the Commission that it no longer wished to be registered as an IVoIP provider in Missouri.

On October 4, 2018, the Commission issued an *Order Establishing Time to Respond* directing staff to file a recommendation. On October 10, 2018, Staff filed a recommendation to cancel Blue Ocean's registration.

No objections or requests for a hearing were filed. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on Blue Ocean's request and Staff's motion and recommendation, the Commission finds that the IVolP registration granted to Blue Ocean shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The registration to provide Interconnected Voice over Internet Protocol services granted to Blue Ocean Technologies, Inc., in File Number DA-2017-0043, is canceled.
2. This order shall become effective on October 22, 2018.
3. This case may be closed on October 23, 2018.
