## ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On November 23, 2022, Crosstalk Solutions, LLC (Company) filed a motion with the Commission requesting cancellation of its Interconnected Voice over Internet Protocol (VoIP) registration. The Company explains that it no longer offers interconnected voice over internet protocol services in Missouri and that the Company has no telecommunications customers in Missouri. The Company also filed a letter with the Commission on November 2, in Tracking No. BCES 2023-0265, requesting the Commission to cancel its authority to provide VoIP services in the State of Missouri. The Commission granted the Company its registration in Case No. DA-2021-0172 on January 1, 2021.

The Commission will direct its Staff to review the notice and file a recommendation regarding cancellation of the Company's registration.

**THE COMMISSION ORDERS THAT:**

1. No later than January 3, 2023, the Staff of the Missouri Public Service Commission shall file with the Commission a recommendation regarding the cancellation of Crosstalk Solutions, LLC's registration to provide IVoIP service.
2. This order is effective when issued.
