ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023

Effective Date: August 23, 2023

On March 23, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the registration to provide interconnected voice over Internet protocol (IVoIP) services of YTEL, Inc. (YTEL or The Company). The Commission granted YTEL a registration in File No. DA-2019-0219.

Staff's motion states that YTEL failed to file an annual report for calendar years 2019, 2020, and 2021. YTEL also failed to file its Statement of Revenue for calendar years 2019, 2020, and 2021. YTEL also failed to pay its annual assessment for fiscal year 2023. Staff recommended that the Commission cancel the Company's certificate.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the registration granted to YTEL shall be canceled.

THE COMMISSION ORDERS THAT:

- The registration to provide interconnected voice over Internet protocol
 (IVoIP) services of YTEL, Inc. granted in File No. DA-2019-0219 is canceled.
 - 2. This order shall become effective on August 23, 2023.
 - 3. This case may be closed on August 24, 2023.
