JOINT STATUS REPORT

COME NOW the Staff of the Missouri Public Service Commission ("Staff") and Respondents (jointly "the Parties"), and in response to the January 9, 2008 Order Directing Status Report, state to the Missouri Public Service Commission ("Commission") as follows:

1. The Staff and the Respondents are diligently working toward a resolution of this matter.
2. On November, 21, 2007, Respondents notified Universal Utilities, Inc. ("Universal") that they do not intend to renew the existing contract that expires this year (2008) with Universal and have requested to negotiate an early termination of that contract.
3. In mid-December of 2007, the City of Columbia, Missouri's municipal utility, Columbia Water and Light, began providing water service to the Blue Acres Mobile Home Park through a prior agreement with Boone County Consolidated Water Supply District #1 (District #1). This development was unrelated to the instant case, and as a result the Respondents are also working with the City of Columbia to address all issues related to the transition to water service provided by Columbia Water and Light.

4. The Staff and the Respondents continue to believe that this matter can be settled and are working diligently towards a resolution of this matter.

WHEREFORE, the Staff and the Respondents respectfully request that the Commission accept this Joint Status Report.
