## ORDER ESTABLISHING TIME TO RESPOND

Effective Date: September 12, 2016

On September 9, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting that Voclarion, LLC's registration to provide interconnected voice over internet protocol service in the State of Missouri be cancelled. On June 5, 2016, the Commission granted Voclarion registration to provide IVoIP services in the State of Missouri in File Number DA-2015-0312. On June 15, 2016, Voclarion notified the Commission that the company no longer wished to be registered as an IVoIP provider in Missouri.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.

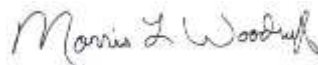

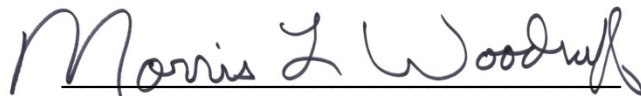
