ORDER CANCELING IVOIP REGISTRATION

Issue Date: August 11, 2021 Effective Date: September 10, 2021

On July 26, 2021, Republic Wireless of North Carolina, Inc. d/b/a Republic Wireless, Inc. (Republic Wireless) notified the Commission that it wishes to cancel its authority to provide interconnected voice over internet protocol (IVoIP) service in Missouri. The Commission granted that registration in File No. DA-2017-0203, on February 10, 2017.

The Commission directed its Staff to respond, and on August 10, 2021, Staff filed a recommendation advising the Commission to cancel Republic Wireless' registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the registration granted to Republic Wireless shall be canceled.

THE COMMISSION ORDERS THAT:

- The registration to provide IVoIP services granted to Republic Wireless in File Number DA-2017-0203, is canceled.
 - 2. This order shall become effective on September 10, 2021.
 - 3. This file may be closed on September 11, 2021.
