FROM PARTICIPATION IN SCHEDULED HEARING**

COMES NOW Cuivre River Electric Cooperative Inc., by and through its attorneys of record Andereck, Evans, Milne, Widger, and Johnson, L.L.C., and for its Request to be Excused from Participation in Schedule Hearing, states as follows:

1. On April 1, 2008, by Order of the Commission, the Application of Wasatch Investments, LC for Change of Electric Supplier was re-instated.
2. The Commission by its April 1st Order Directed the Parties to file a proposed hearing date or briefing schedule by no later than April 14, 2008.
3. The Commission's April 1st Order furthermore provided that in the event of a hearing date being set, any party could, at least two weeks prior to the hearing, request to be excused from participation in the hearing.
4. An April 15, 2008, by Order of the Commission, a hearing in this matter was set for June 11, 2008.


