ORDER CANCELING IVOIP REGISTRATION

Issue Date: September 1, 2021 Effective Date: October 1, 2021

On August 24, 2021, Ionex Communications, Inc. notified the Commission that it wishes to cancel its authority to provide interconnected voice over internet protocol (IVoIP) service in Missouri. The Commission granted that registration in File No. DA-2019-0358, on May 31, 2019.

The Commission directed its Staff to respond, and on September 1, 2021, Staff filed a recommendation advising the Commission to cancel lonex Communications' registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the registration granted to lonex Communications shall be canceled.

THE COMMISSION ORDERS THAT:

The registration to provide IVoIP services granted to lonex
 Communications in File Number DA-2019-0358, is canceled.
