## ORDER CANCELING IVOIP REGISTRATION

Issue Date: January 12, 2022

Effective Date: February 11, 2022

On December 15, 2021, AuraVox, LLC notified the Commission that it wishes to cancel its authority to provide interconnected voice over internet protocol (IVoIP) service in Missouri. The Commission granted that registration in File No. DA-2015-0333, on July 6, 2015.

The Commission directed its Staff to respond, and on January 5, 2022, Staff filed a recommendation advising the Commission to cancel AuraVox, LLC's registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the registration granted to AuraVox, LLC shall be canceled.

### THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP services granted to AuraVox, LLC in File Number DA-2015-0333, is canceled.
2. This order shall become effective on February 11, 2022.

3. This file may be closed on February 12, 2022.
