### ORDER CANCELING AUTHORITY

Issue Date: May 12, 2023 Effective Date: June 11, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the registration of Harbor Communications, LLC (Harbor or the Company) to provide interconnected voice over internet protocol (IVoIP) services in Missouri. In File Number DA-2017-0141, the Commission granted Harbor authority to provide IVoIP services.

Staff's motion states that Harbor failed to submit an annual report due to the Commission for calendar year 2021. In addition, the Company failed to file its Statement of Revenue report and pay the annual assessment for fiscal year 2023. Staff recommended that the Commission cancel the Company's registration of service authority. The Company has not responded to Staff's contacts to resolve these deficiencies.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. Harbor responded on April 24, 2023, indicating

that it wished to voluntarily surrender its registration to provide IVoIP services in Missouri.

Based on Staff's motion and the request of Harbor, the Commission finds that the registration of service authority granted to Harbor shall be canceled.

#### THE COMMISSION ORDERS THAT:

- 1. The registration of service authority to provide IVoIP services in Missouri, granted to Harbor Communications, LLC in File Number DA-2017-0141, is canceled.
  - 2. This order shall become effective on June 11, 2023.
  - 3. This case may be closed on June 12, 2023.
