ORDER GRANTING INTERVENTIONS AND SETTING PROCEDURAL SCHEDULE

On September 4, 2013, KCP&L Greater Missouri Operations Company ("GMO") filed the above referenced application and tariff. GMO filed a similar, if not identical, tariff in File ET-2014-0026, which is now closed. In File ET-2014-0026, the parties agreed that they should become parties in File No. ET-2014-0059. Thus, the Commission, *sua sponte*, grants intervention in File No. ET-2014-0059 to all the parties from File No. ET-2014-0026.

GMO, on behalf of all the parties, also filed a proposed procedural schedule. As GMO correctly notes, HB 142 requires the Commission to rule on this filing within sixty days. The Commission finds that in order to meet this expedited mandate, it must alter and accelerate the schedule.¹

THE COMMISSION ORDERS THAT:

1. All parties in File No. ET-2014-0026 are granted intervention and are hereby parties in File No. ET-2014-0059.

¹ Also, because this case will be the first HB 142 case before the Commission, the parties' request to give closing statements in lieu of briefs will be denied. The Commission will need further written argument from the parties after the hearing.
