On October 2, 2018, Blue Ocean Technologies, Inc. ("Blue Ocean") notified the Commission that the company no longer wished to be registered as an IVolP provider in Missouri.

The Commission granted Blue Ocean's registration to provide IVolP services in the State of Missouri in File Number DA-2017-0043.

The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of Blue Ocean's IVolP registration.

### THE COMMISSION ORDERS THAT:

1. No later than October 24, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation regarding the request of Blue Ocean to cancel its IVolP registration.
2. This order shall be effective when issued.
