ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On August 10, 2022, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the registration of interconnected voice over internet protocol (IVoIP) service authority of ConvergeOne Unified Technology Solutions, Inc. (Company). On August 30, 2018, the Commission granted a registration to the Company to provide IVoIP services in File No. DA-2019-0057. The Staff's motion states that the Company requested the Commission to cancel the IVoIP authorization of the Company.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or to request a hearing shall do so by filing a pleading no later than August 22, 2022, with:
