ORDER CANCELING IVOIP REGISTRATION

Issue Date: December 27, 2022

Effective Date: January 26, 2023

On December 13, 2022, the Commission's Staff filed a motion asking the Commission to cancel the IVolP registration of VoicePro, Inc. The Commission granted VoicePro that registration in File No. DA-2014-0206, effective January 31, 2014.

Staff explains that VoicePro notified the Commission in a November 30, 2022 letter that it does not serve any customers in Missouri and asked the Commission to cancel its registration. Staff indicates VoicePro's request to cancel its registration is in compliance with Commission Rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that registration.

On December 13, 2022, the Commission issued an order allowing parties until December 23, 2022, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on the company's request, and Staff's motion, the Commission finds that the registration granted to VoicePro shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP services granted to VoicePro, Inc. in File Number DA-2014-0206 is canceled.
2. This order shall become effective on January 26, 2023.
3. This file may be closed on January 27, 2023.
