On August 22, 2023, the Staff of the Commission (Staff) filed a *Motion to Cancel Interconnected Voice Over Internet Protocol Registration*. BTC, Inc. filed a letter with the Commission on August 16, 2023, (Tracking No. BCES-2023-0093) asking the Commission to immediately cancel its certificate number F001326009 as it is no longer doing business in the State of Missouri. The certificate had been granted to BTC, Inc. for Interconnected Voice Over Internet Protocol (VoIP) authority in File No. DA-2017-0116 on November 18, 2016.

The Commission will establish a time for interested parties to file an objection or request a hearing.

THE COMMISSION ORDERS THAT:

1. Any parties wishing to object to Enqwest's request to cancel its VoIP registration or to request a hearing shall do so no later than September 14, 2023.
2. This order shall be effective when issued.
